3. Universal Basic Income (UBI): Promise and Weaknesses

- UBI offers unconditional cash support and can cushion households during transition, reduce poverty, and simplify welfare systems.
- Weaknesses: Cost of meaningful UBI is extremely high; enforcement and accountability are lacking; UBI does not build skill pathways; equity concerns.

4. A Citizen Workforce Protection Agency via Executive Order

• Executive action is the only lever fast enough to set procurement conditions, disclosure rules, and enforcement thresholds now.

- Structure & Powers: Mandatory automation disclosure; enforcement tools; receivership/trustee power; retraining & wage insurance; equity/gain sharing.
- Citizen Oversight & Accountability: Rotating, diverse citizen commissions; transparent dashboards; legal safeguards and appeal rights.

5. National Security & Existential Stakes

- Unmanaged displacement undermines tax bases, strains public services, and frays social cohesion—core components of national resilience.
- If automation proceeds without public oversight, we risk drifting toward command-style power structures devoid of democratic accountability.

6. Objections & Safeguards

- To prevent overreach: clear legal thresholds, due process, appeal mechanisms, and limits on emergency powers.
- Cost concerns addressed via automation dividends, productivity surcharges, procurement leverage.
- Guarding against capture: rotating citizen panels; independent auditing; transparency in decision-making.

7. Recommended First Steps

- 1. Issue an Executive Order establishing the WPA and baseline powers: disclosure, procurement conditions, enforcement, wage insurance.
- 2. Amend federal contracting policy to require automation impact reporting and mitigation.
- 3. Pilot WPA in high-automation sectors or states.
- 4. Build a coalition (labor, think-tanks, national security community) for broader adoption.
